8.07	Rates	IJ attended Council meeting last night and asked a question regarding if the Council will classify home based businesses as commercial for rating purposes. Mitchell advised these are set by the Valuer General. Mayor Kons advised he will follow up directly with the Valuer General and respond. AW advised new AAVs had just been performed - hard to quantify the increase in commercial due to the sale of several large sites in recent times.		
8.08	Tasmanian Energy Management conference	IJ attended this two day conference in Devonport and reported on Day 1. The key to the future of renewable energy in Tasmania is the approval of Project Marinus. A survey ship has been offshore recently mapping potential routes for the cable.		
		Robbins Island project is progressing well albeit a bit of bad PR with the proposed route going through Leven Canyon. The CEO of UPC Renewables; Anton Rohner advised IJ they are working on alternate route.		

TA asked re electricity prices. IJ was able to advise that Tasmanian prices are among the lowest in the nation.

IJ met with the Coordinator General John Perry who advised that Hydrogen could provide a major export for Tasmania especially to Japan that wants clean green sourced hydrogen as a major part of its energy by 2030. If Marinus on-shores at Burnie then combined with our deep water port we should be in a good situation to attract the establishment of the chemical plant.

DP: Councillor Dorsey discussed a CBD business group and the informal retail group becoming a formal group but Chamber needs to be advised. DP said that the group needs to represent all those businesses in the CBD and not just retailers. IJ said that the retail group could be part of the Chamber with it having its own meetings but with a position on the Chamber Executive much the same as the tourism group that will vote to join BCCI at it next AGM. ML said that the Advocate has been responsible for the demise of Burnie and the lack of vibrancy. JP said he thought it was more due to TasPorts.
